- 2) Declarations of Interest Cllr Bingham re payments
- 3) Minutes the minutes of Parish meeting 21st may were **APPROVED** and **SIGNED**.

 - Village Hall curtains Cllr Bingham has obtained 2 quotes for a curtain pole; however, the curtains are too high for a pole and need to be upgraded to a track. The quote is approximately £1200. A third quote has been sought.
- 6) County / Borough Councillor updates: Cllr Soloman reported that they had received a concern from a resident over safe walking routes but not there was little that could be done due to surrounding vegetation.

Several complaints have been received regarding Manor Lane. Suggestions have been to clear the vegetation, widen the road or make the road oneway. It is a County Council issue however, Cllr Soloman requested that a formal suggestion from Shelford PC be submitted, and it can then be sent on to Cllr Upton.

A recommendation has been submitted by RBC for the proposed restructure of the borough and county councils. The outcome of the proposals is due in November.

7) New playground equipment – Council discussed the recent site meeting with Proludic. Council **NOTED** the need to install a path to access the gym equipment. It **RESOLVED** to lay grass seed / wildflowers on the banking area to make more of this feature.
